Council to Hold Public Hearings on Amendment 11 to the Atlantic Mackerel, Squid, and Butterfish FMP

The Mid-Atlantic Fishery Management Council will hold hearings on Amendment 11 to the Atlantic Mackerel, Squid, and Butterfish Fishery Management Plan (FMP) to receive public input on management actions under consideration in the Amendment. There are 7 proposed management actions that could:

in February 2010

- 1-4: Create a tiered limited access system in the Atlantic mackerel fishery
- 5 : Update Essential Fish Habitat (EFH) designations for all species in the MSB FMP.
- 6 : Establish a percentage allocation between the recreational and commercial mackerel sectors
- 7 : Establish limitations on at-sea processing via at-sea transfers in the mackerel fishery (i.e., processing by mother ships)
