I. Introduction, Announcements, Comments.

Alicia Nelson explained that the 2021 RFAB meeting dates had not yet been set; however, applications for the 2021 funding cycle will be due April 15, 2021. Mr. Jessie motioned to approve the item. Mr. Holland seconded the motion, and the motion passed unanimously.

VI. Access Projects

L) 0420-12 Reconstruction of a Saltwater Fishing Pier on the Severn River. L. Lawrence, MPPDC. \$50,000.

Mr. Rhodes noted that Mr. Lawrence had already provided a signed VMRC Facility Grant Provision Checklist, and reviewed the items with the board. He noted that the only one that was not typical was the item referring to law enforcement at the pier because the MPPDC is not the municipality in charge of enforcement.

Ms. Nelson explained that enforcement activities and jurisdictions would not shift in this case because it was not a new pier location. Mr. Southall asked about the rest of the checklist items and how they applied to this case. Ms. Nelson explained that the checklist is standard for all projects, so that not each item applies as much to this project (a reconstruction). The most important items for this case were the replacement and insurance items, as well as the item about the pier being free at this time to the public.

Mr. Southall motioned to approve the item. Mr. Randolph seconded the motion, and the motion passed unanimously.
