REGULATION 450-01-0054

PREAMBLE

This regulation prohibits the use of patent tongs on Public oyster grounds within the James River. This regulation is promulgated pursuant to authority contained in §28.2-201 of the Code of Virginia. This regulation amends and re-adopts previous Regulation 450-01-0054, which was adopted April 4, 1989 and effective April 5, 1989. The effective date of this regulation is July 1, 1995.

§1. PURPOSE:

The purpose of this regulation is to conserve and protect the Public oyster grounds in the James River.

§2. DESCRIPTION OF AREA:

This regulation shall include all of the Public oyster grounds in the James River upstream of the James River bridge.

§3. VIOLATIONS:

It shall be unlawful for any person to use or operate patent tongs in any manner on any Public oyster grounds in the James River upstream of the James River bridge.

§4. PENALTY:

As set forth in §28.2-903 of the Code of Virginia, any person violating any provision of this regulation shall be guilty of a Class 3 misdemeanor, and a second or subsequent violation of any provision of this regulation committed by the same person within twelve months of a prior violation is a Class 1 misdemeanor.
