ALTERNATE EIGHT-HOUR LAWFUL DAILY TIME LIMIT RESTRICTIONS, PURSUANT TO REGULATION 4VAC20-270-10 et seq. (Subsection 30 C).

- Permit will allow legal commercial crab pot or peeler pot licensee to take and harvest crabs by crab pot or peeler pot, or to retrieve, bait or set those crab pots or peeler pots one hour earlier than described in subsection A, only for the months of June, July, August and September.
- Once any legal crab pot or peeler pot licensee obtains an alternate eight-hour daily time limit permit, that permittee shall be legally bound by the alternate eight-hour daily time limit through September 30.
- Permitted individual must carry the signed approval form (permit) during all commercial harvesting activities and present the form to any police officer if requested. If permitted individual has an authorized agent, that agent will be held to the alternate daily time limit and must carry the signed approval form (permit) at all times.
- It shall be unlawful for two or more licensed crab pot or peeler pot fishermen, or their agents, to crab aboard the same vessel if their authorized eight-hour daily time limits are not identical.
- After January 1, 2012, requests for an alternate eight-hour time limit permit shall be submitted to the Marine Resources Commission annually and prior to May 15. Requests submitted on or after May 15 will not be considered.
